Application and Reservations

A *non-refundable deposit of \$150.00 per person is required when your application is submitted and full payment is due 30 days prior to the Trip departure date. If a reservation is made for a trip within 30 days of the scheduled departure date, the entire amount is due at the time of confirmation. All Cousin Trips travelers must complete a Cousin Trips Application and sign the General Terms & Conditions to confirm program participation.

International & Domestic Airline Ticket (when applicable)

The sole and exclusive responsibility and liability of any carrier used in conjunction with Cousin Trips shall be in accordance with and is limited by the contract of carriage in the passenger's ticket. Any inconvenience caused by that carrier is not the responsibility of Cousin Trips. Domestic airfare from your home city to the trip departure city is not included in the program price.

Ground Transportation

All Cousin Trips will originate from and return to Atlanta, GA. Ground and or air transportation will be provided from Atlanta to the Trip destination. Trip price does not include transportation from your home city to Atlanta, GA.

Accommodations

Resort accommodations are 2 or 3 bedroom condominium units. Participants will sleep 2 or 4 to a room with private facilities. Single rooms are not available on Cousin Trips.

Meals

Breakfast, Lunch and Dinner are provided daily.

Tours / Entrance Fees / Gratuities (when applicable)

Entrance fees to museums, monuments, parks, and tours outlined on the itinerary are included in the package price. Gratuities for tour leaders, drivers, and escorts are also included in the package price.

Baggage

Cousin Trips travelers are allowed one suitcase and one backpack **or** personal bag.

Cancellations and Refunds

Refunds will be paid (excluding the non-refundable deposit of \$150.00) based on the following schedule

- 90 days or more prior to departure – Full refund
- 60-89 days prior to departure – 75% of payment refunded
- 30-59 days prior to departure – 50% of payment refunded
- Less than 30 days prior to departure – No refunds issued
